2022 HONORARY MAYOR OF BRANDONSM RACE • STANDING



I. GENERAL

1. The Honorary Mayor of BrandonSM Race shall begin June 1, 2022.
The Honorary Mayor of BrandonSM Race shall end at 8 AM, July 4, 2022.
2. The geographic area identified herein as “the Greater Brandon area” (also referred to herein as “Brandon”) includes the area bounded by the FishHawk subdivision to the south, Interstate 4 to the north, Turkey Creek Road to the east, and U.S. Highway 301 to the west.

II. ELECTION/TABULATION OF MONEY

1. The candidate submitting the most money to The Community Roundtable for tabulation shall be named Honorary Mayor of BrandonSM (also referred to herein as the Honorary Mayor or Mayor).
2. Tabulation of money shall be conducted by the President and/or Treasurer of The Community Roundtable in the presence of the current Honorary Mayor, each candidate, and one representative of each candidate.
3. Once assembled to tabulate the money, the President shall request the candidates put forth and identify all money being submitted for tabulation. Only cash or a cashier's checks drawn on an account owned by the sponsoring organization and payable to The Community Roundtable shall be accepted. When all candidates have submitted their money, the President shall announce that the submission is closed and tabulation will begin. No money will be accepted after the President announces that the submission is closed.
4. Once the tabulation of the money has begun, no one will be permitted to enter or leave the tabulation room until all money has been counted.
5. The order of tabulation of money shall be alphabetical by the last name of the candidate.
6. Any candidate submitting a check for tabulation which is returned for any reason, shall pay The Community Roundtable the face value of the check plus any bank charges incurred by The Community Roundtable within ten (10) days of demand.
7. No money may be collected or received by or on behalf of a candidate before the start of the Mayor's Race which begins on June 1, 2022 and ends on July 4, 2022 at 8 AM. No membership dues, initiation fees, or other like fees or costs shall be submitted to The Community Roundtable for tabulation.
8. All decisions of The Community Roundtable Board concerning the tabulation of money shall be final.
9. The President and/or Treasurer shall announce the name of the new Honorary Mayor.

III. FUNDRAISING

1. The Community Roundtable Board has the authority to approve or reject any activity used to raise funds.
2. The direct solicitation of funds is neither prohibited nor encouraged; rather, The Community Roundtable expresses its preference that direct solicitation be kept to a minimum and the proceeds of community events be submitted for tabulation. All activities will be pre-approved by The Community Roundtable Board.
3. The Community Roundtable requests that candidates conduct themselves and their campaigns in accordance with the decorum of the office sought.

4. The Community Roundtable assumes no liability for the safety of anyone participating in any event and each candidate is encouraged to obtain appropriate insurance.
5. The Community Roundtable assumes no responsibility for the legality of any fundraising methods and encourages all candidates to determine for himself or herself that such methods comply with all local, state, and federal laws and ordinances.
6. Planning for a candidacy and fundraising events may begin prior to the beginning of the Mayor's Race. Deposits for events may be made and supplies purchased prior to the beginning of the Mayor's Race.
7. No funds shall be collected until June 1st and funds will not be accepted after 8 AM on July 4th.

IV. TERMS OF OFFICE/SUCCESSION

1. The Honorary Mayor shall take office upon being named and shall serve a term of one (1) year.
2. Once named as Mayor, that person will not be eligible for the position again.
3. Mayor shall participate and be visible in the greater Brandon area to maximize exposure of The Community Roundtable organization. Events include, but not limited to:

Cards for Troops - October

Lighting of the Christmas Tree - December

Community Affairs Dinner - February

Golf Tournament - March

V. DISBURSEMENT OF MONEY SUBMITTED

1. Monies submitted to The Community Roundtable for tabulation in connection with the Mayor's Race shall be disbursed as follows:

Seventy five Percent (75%)

Ten Percent (10%)

Fifteen Percent (15%)

Designated Charity(ies)

Sponsoring Organization

2. The Community Roundtable will disburse money submitted for tabulation at the next regularly scheduled meeting of The Community Roundtable.
3. Candidates may waive disbursement allocation to sponsoring organization in favor of designated charity.

VI. APPLICANT/CANDIDATE

1. Applications will be reviewed by The Community Roundtable Board Mayoral Committee and applicants will be approved for candidacy.
2. Candidates must live, work, or volunteer in Brandon.
3. Candidates must be at least 21 years of age.
4. Candidates not receiving the Mayoral title may reapply to run for the Honorary Mayor of Brandon SM position in subsequent years.

VII. SPONSORING ORGANIZATION

1. The sponsoring organization must be designated as a **Brandon** 501(C)(3) charity. Sponsoring organizations serve as campaign treasurer, assist with the campaign, provide volunteers, organize fundraising events, and pay invoices for such events.
2. The sponsoring organization must be a member of The Community Roundtable.
3. The candidate may designate only one (1) sponsoring organization.
4. The sponsoring organization may also be one (1) of the three (3) designated charities.

VIII. DESIGNATED CHARITY(IES)

1. Designated charity(ies) must be registered as a 501(C)(3) and have one or more of the following ties with Brandon: an office in Brandon, documented service to the Brandon community, or membership drawn primarily from Brandon residents.
2. All designated charities shall benefit the greater Brandon community.
3. The candidate may designate no more than three (3) charities.

IX. APPLICATION/APPLICATION FEE

1. Each candidate shall submit their application on the official Community Roundtable form by May 1, 2022.
2. Each candidate shall pay an application fee of \$50 (to be refunded should the application be denied).
3. The Community Roundtable Board reserves the right to reject any application.

X. DISQUALIFICATION

1. Should the winning candidate be disqualified for any reason, The Community Roundtable Board will designate the successor.

XI. ROUNDTABLE BOARD MEMBERSHIP

1. The new Honorary Mayor becomes a member of The Community Roundtable Advisory Committee, abides by its Bylaws, and serves as an ambassador of the organization.

XII. MISCELLANEOUS

1. Each candidate shall meet with The Community Roundtable's Mayoral Race Committee to review the duties and expectations of the Honorary Mayor prior to the beginning of the race.
2. The Honorary Mayor must be available to ride in the Fourth of July Parade.
3. The Honorary Mayor performs ceremonial duties as approved by The Community Roundtable Board.
4. All communications including Social Media must be pre-approved by The Community Roundtable Board.
5. Only the current Honorary Mayor may present Proclamations. All Proclamations must be pre-approved by The Community Roundtable Board.
6. The Community Roundtable assumes NO liability for the safety of anyone participating in any event and candidates are encouraged to obtain appropriate insurance.

Candidates are required to comply with the current rules.

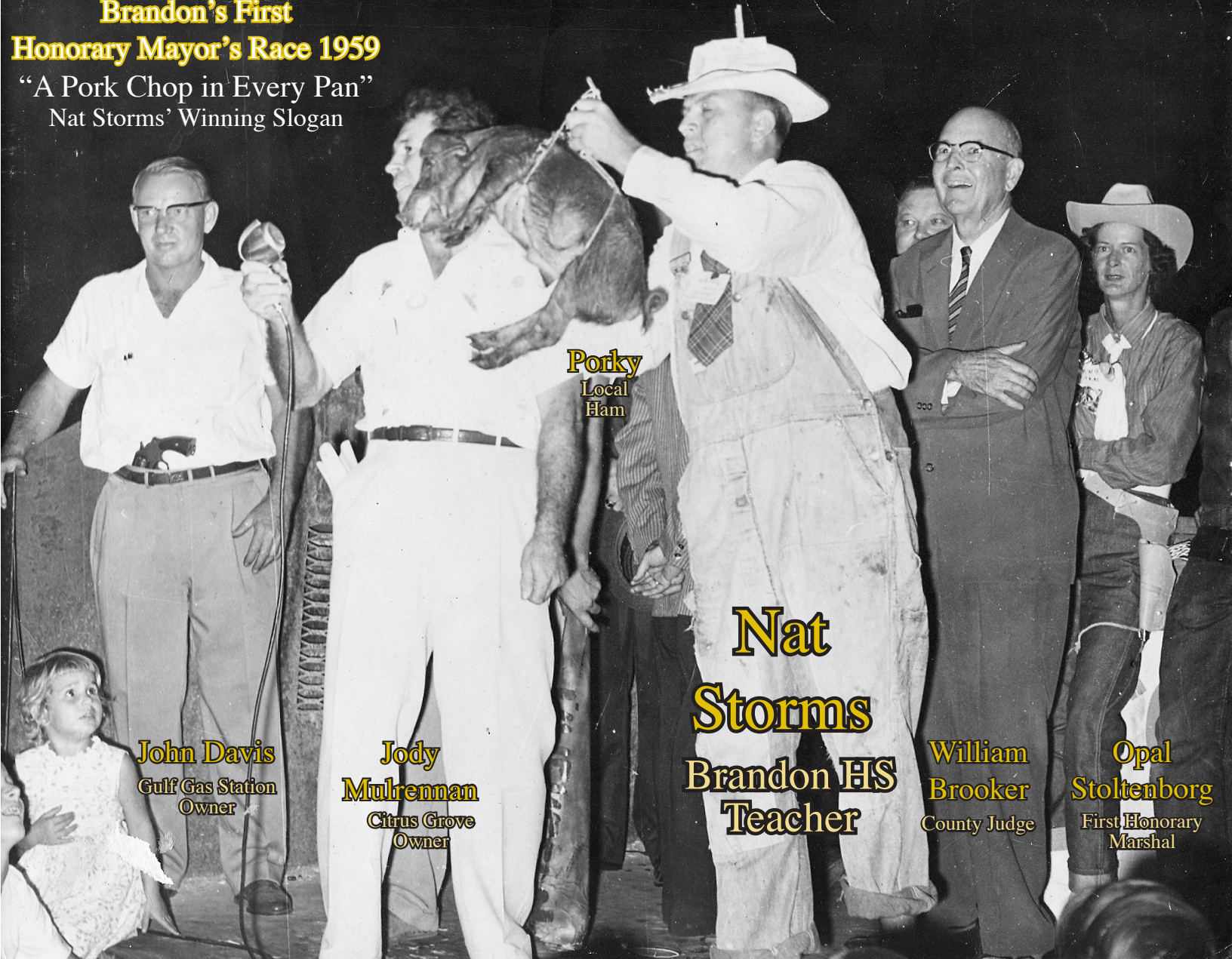
